



# TEACHAIREACHD Chairperson's message A' CHATHRAICHE

Tha MG ALBA – Seirbheis Meadhanan Gàidhlig na h-Alba – agus an luchd-obrach air fad air obrachadh gu cruidh sa bhliadhna a dh'halbh gus dèanamh cinnteach gun tèid leantainn air adhart a' craoladh raon farsaing de phrògraman aig àrd ire ann an Gàidhlig air BBC ALBA. Tha sinn air seo a dhèanamh a dh'aindeoin isleachadh ann an luach ar buidseat agus ann an àrainneachd craolaidh a tha ag atharrachadh agus a tha dùblanach. A' coimiseanadh raon de phrògraman ùra bho thàlant chruthachail na h-Alba, tha sinn air a bhith innleachdach an cois co-bhanntachd a' BhBC air susbaint air leth a libhrigeadh do phìomh luchd-cleachdaidh BBC ALBA agus do mhòran eile air feadh Alba.

Coltach ri iomadach seanaill loidhneach eile, tha dùblanach sòraichte aig BBC ALBA. Tha luchd-amhairc fo aois 45 a' coimhead nas lugh a telebhisean agus tha seo cho fior airson luchd-amhairc na Gàidhlig 's a tha e airson luchd-amhairc eile. Tha an dùblan seo nas duilghe buileach do BhBC ALBA ri linn 's gu bheil cuingealachaidhean maoineachaiddh a' cur bacadh air an àireamh de phrògraman ùra a tha air an t-seanail, a' ciallachadh pàtral de dh'ath-chraoladh a tha a-nis an iùre mhath neosheasmhach.

Ach, tha adhbharan dòchais ann. Chan eile làire sam bith oirnn a bhith a' cur fòcas air ar luchd-amhairc òga agus tha sinn a làn chreidsinn le bhith nas èifeachdaich agus le bharrachd stuth air ùrlaran didseatach gu bheil sinn a' leasachadh seirbheis a tha feumail is misneachail do luchd-cleachdaidh na Gàidhlig. 'S e sin ar priomh amas.

MG ALBA – Scotland's Gaelic Media Service - and all its staff have worked hard over the past year to ensure the continued broadcasting of a wide and diverse range of high-quality programmes in Gaelic on BBC ALBA. We have done so despite an unfortunate trend of real terms decline in our budget and in a changing and challenging media environment. Commissioning a range of new programmes from Scotland's array of creative talent, we have nonetheless ensured that our partnership with the BBC has delivered excellent content to BBC ALBA's core audience and to many other viewers in Scotland.

In common with many other linear channels, BBC ALBA itself continues to face particular challenges. Linear media consumption for audiences under 45 is reducing and this is as true for the Gaelic audience as it is for others. This challenge is compounded for BBC ALBA because funding constraints continue to limit the channel's number of first-run hours and therefore force a repeat pattern which is becoming unsustainable.

However, there are reasons for optimism. We are unashamedly focusing on younger audiences and believe that effective targeting and a stronger presence on digital platforms has enabled our content to remain relevant, useful and inspiring for the Gaelic audience. This is our core purpose.

Tha ioma cothrom an lùib seanail ùr a' BhBC, BBC Scotland, agus aig an ìre seo, tha ar coimiseanairean ag obair gu dlùth leis a' BhBC gus dèanamh cinnteach gu bheil co-obrachadh ann a bheir leasachadh air seirbheis do luchd-cleachdaidh na Gàidhlig fhad 's a tha roghainnean agus luach a bharrachd aig muinntir Alba gu lèir.

Tha mòran adhbharan dòchais am measg nam meadhanan chruthachail. Tha stèidheachadh Aonad Sgrion airson Alba le buidseat bliadhnailean de £20m agus seanail ùr a' BhBC le buidseat bliadhnailean de thimcheall air £30m na phiseach chudromach airson na roinne, a thuilleadh air gealladh bhon BhBC agus bho Seanail 4 leudachadh air na thathar a' dèanamh de phrògraman ann an Alba airson a' chòrr den Rìoghachd Aonaichte.

Tha na tha MG ALBA a' cur ris an roinn chruthachail glè chudromach. Le BBC ALBA an urra ri cha mhòr leth de na h-uairean a thìde a thathas a' craoladh bho chompanaidhean neo-eisimeileach tha MG ALBA a' cur gu mòr ri leasachadh na roinne agus cumaigh sinn a' co-obrachadh le Alba Chruthachail agus na buidhnean leasachaiddh agus trèanaidh gus tòlant cruthachail, àrach a bhios maireannach is cho math 's a th' air feadh an t-saoghal.

Tha sinn air a dhol ri dùbhlain a bhith tlachdmhor do luchd-cleachdaidh fo aois 45 - far a bheil beairteas is lìonmhorachd de stuth ri fhaighinn air iomadh inneal - le dhol an sàs ann a bhith a' cruthachadh stuthan a tha nas dàine, tuilleadh obrach air comadaidh agus dràma, brosnachadh agus trèanadh de sgriobhadairean ùra le compàrtichean leithid Writers' Room a' BhBC agus feadhainn eile, agus cuideachd le bhith a' cur fòcas air stuthan goirid, èibhinn air na meadhanan sòisealta.

Chòrd am prògram-aithris **Ceathrar air a' Chuiltheann**, sgeulachd cheathrar dheugairearan a' toirt ionnsaigh air a' Bhinnean Do-Ruigsinneach, gu mòr ris an luchd-amhairc agus bha e air leth tlachdmhor **Sùlaisgeir**, an sàr phrògram-aithris mu shealgairean a' ghuga, aithne fhaighinn aig Fèis TBH Eadar-nàiseanta Chicago agus **Eòrpa Special – Guantanamo Detainees** a' buannachadh a' phrògram Cùisean Làitheil As Fheàrr aig Duaisean BAFTA Alba 2017.

The planned new BBC channel, BBC Scotland, affords many opportunities and, at this early stage, our commissioners are working closely with BBC colleagues to ensure complementarity and a mutual commitment to increase the service to our Gaelic audience as well as providing greater choice and value to the people of Scotland.

There is much to be optimistic about in the creative industries. The setting up of a Screen Unit for Scotland with an annual budget of £20m and the proposed new BBC Channel with an annual budget of around £30m is an important boost for the sector along with commitments from the BBC and Channel 4 to increase network spend in Scotland.

MG ALBA's contribution to the sector remains significant, with BBC ALBA accounting for around 50% of independently produced hours for audiences in Scotland. MG ALBA has an important role to play in the sector's development and we will continue to work alongside Creative Scotland and the development and training agencies to foster creativity, sustainability and world-class talent.

Our practical support and encouragement for many of our independent production companies to seek international co-productions is currently forecast to bring additional value of over £4m to our audiences. This is a remarkable achievement by small creative businesses who operate in a creative and innovative manner both locally and globally.

All of this work is in the service of our audience. The challenges of serving the under-45 audience in an ever-expanding plethora of content, has been met by bolder content, a bigger commitment to comedy and drama, encouraging and training new writers with partners such as the BBC Writers' Room and others and also by focusing on targeted shorter and pithier content on social media.

The documentary, **Ceathrar air a' Chuiltheann**, the story of four teenagers' quest to conquer the most challenging climb, The Inaccessible Pinnacle, was a great audience success and it was very rewarding to see **Sùlaisgeir**, the acclaimed documentary on the guga hunters, achieve international recognition at the Chicago International TV Festival, and **Eòrpa Special – Guantanamo Detainees**, winning Best Current Affairs programme at the BAFTA Scotland Awards 2017.

Tha ar dealas a thaobh luchd-ionnsachaidh na Gàidhlig a' leantainn le prìomhachas nas mothà ga thoirt do LearnGaelic.scot. Tha sinn ag obair gu dlùth le Bòrd na Gàidhlig agus feadhainn eile gus dèanamh cinnteach gu bheil na goireasan airson an iomadh neach a tha ag ionnsachadh na Gàidhlig ioma-chuimseach agus co-aimsireil. 'S fhada bho bha feum air prògram ionnsachaidh Gàidhlig airson na 21<sup>th</sup> linn agus tha sinn ag obair le raon farsaing de chom-pàirticean ann an oidharp sin a choileanadh.

Tha fior dheagh thoradh ri fhaicinn anns an obair gus daoine òga le comas-labhairt na Gàidhlig a bhrosnachadh gus a bhith a' cruthachadh stuthan-mheadhain. B' e seo a' bhliadhna a b' fheàrr fhathast airson feabhas agus àireamh fhilmichean goirid FilmG. Bha a' mhisneachd agus an tàlant an lùib nam filmichean gu h-àraidh làidir am-bliadhna, le deugairean le Gàidhlig comasach agus deònach aghaidh a chuir air cuid de na cuspairean as dùblanaiche nar saoghal, a thuilleadh air a bhith a' sealltainn gu bheil àbhachdas dha-rìribh beò ann an coimhearsnachd dhualchasach na Gàidhlig.

Tha sinn air cur ri co-chomhairleachadh Ofcom mu uallach reachdail ùr a thaobh a' BhBC. Tha sinn air togail air cho cudromach 's a tha e soilleireachadh a dhèanamh air na targайдean airson BBC ALBA, a' dèanamh cinnteach gu bheil iad brìgheil agus gu bheil iad a' leantainn ri bhith a' cur ri feumalachd is tlachd an luchd-amhairc. Tha sinn den bheachd gu bheil fhathast dith cothromachd ann eadar dealas a' BhBC a thaobh S4C agus BBC ALBA. Tha sinn gu làidir den bheachd gum bu chòir don BhBC poileasaidh soilleir a nochdadh do mhion-chàin air feadh na RA agus, mar phàirt den sin dèanamh cinnteach gu bheil cothromachd nas mothà ann eadar na thathas a' cosg den chìs-chraolaidh air S4C agus BBC ALBA.

Tha soirbheas BBC ALBA an urra gu mòr ri dicheall, sgil agus obair chruaidh an luchd-obrach againn fhèin agus an iomadh compañaidh neo-eisimeileach agus luchd-dèanamh phrògraman a' BhBC. Tha mi fada nan comainn airson an t-seirbheis a tha iad a' toirt dhar luchd-cleachdaidh agus dhan t-seanail. Tha mi cuideachd taingeil airson an obair ionmholta a tha sàs anns na raointean cudromach eile leithid FilmG agus LearnGaelic.

Tha mi cuideachd gu mòr an eisimeil Bòrd MG ALBA airson an cuid ghliocais, eòlais agus airson sàr obair.

**MAGAIDH CHOINEAGAN | CATHRAICHE**

Our commitment to learners of Gaelic continues with greater priority given to LearnGaelic.scot. We are working closely with Bòrd na Gàidhlig and others to ensure the provision for the many who are engaged in learning Gaelic is comprehensive and contemporary. The need for a 21<sup>st</sup> Century Gaelic learning programme is long overdue, and we are engaging with a range of partners in a bid to make that happen.

Our commitment to encourage young Gaelic speakers to create media is bearing great results. The quality and quantity of short film entries for FilmG was the best to date. The confidence and talent involved in producing the films was particularly significant this year with Gaelic youth able and willing to tackle some of the most challenging issues in our society as well as highlighting that great humour is alive and kicking in our Gaelic heartland.

We have contributed to Ofcom's consultations on its new regulatory responsibility regarding the BBC. We have highlighted the importance of having clarity regarding the targets for BBC ALBA, ensuring they are meaningful and continue to enhance the audience experience. We believe there is still a lack of parity between the BBC's commitment to S4C and BBC ALBA. We continue to argue that the BBC should develop a clear policy for and commitment to minority languages across the UK and, as part of that ensure there is greater parity between licence fee spend on S4C and BBC ALBA.

The success of BBC ALBA depends on great dedication, skill and hard work from our own staff and the many independent companies and BBC programme makers who deliver our content. I am very grateful to all of them for their important contribution to the channel and to the audience as well as the other important areas such as FilmG and LearnGaelic.

I am also much indebted to the wisdom, expertise and commitment of the Board of MG ALBA.

# LÈIRMHEAS AN ÀRD- OIFIGEIR

Chief Executive's review

## FOIR-SHEALLADH

B' e bliadhna dhùbhlachanach do MG ALBA a bha ann an 2017-18 ach bha cuideachd comharran gealltanais ann.

Ged a chùm an àireamh de luchd-amhairc a bha a' coimhead an t-seirbhais telebhisein air a' dol sios, mheudaich còrdadh agus mothachadh air an t-seirbhais. Bha an lùghdachadh san àireamh a bha a' coimhead an telebhisein na bu nocte a thaobh luchd-cleachdaidh na Gàidhlig san raon aois 16-44.

Mar fhreagairt air sin, chruthaich sinn san luchair 2017 Aonad Dìseatach, a' tarraing luchd-obrach còmhla le ro-innleachd dhealasach gus daoine òga a chur an sàs ann an susbaint Gàidhlig air telebhisean, air innealan agus air ùrlaran neo-thbh. Tha tràth shoirbheasan agus fàilligidhean a' cuideachadh ann a bhith a' togail an àirdé gu luath eòlas agus fiosrachadh, agus tha sinn misneachail gum bi e cornasach dhuinn ruighinn a-mach chun raon aoise sin, as lugh a tha a' cleachdadadh na seanail loidhneach leis an ro-innleachd ùr dhidseatach againn.

Aig an aon àm, tha sinn a' cur fòcas air a bhith a' tabhann air BBC ALBA susbaint phrògraman a tha nas bragail, nas soilleir agus air a shanasachd nas fheàrr agus aig am bi an comas a bhith a' tàladh luchd-amhairc nas òige. Chuidich seo ann a bhith a' libhrigeadh seusan Nollaig làidir air BBC ALBA, far an do ràinig àireamh an luchd-amhairc aois 16-44 rè ùine nan irean aig an robh iad ann an 2014, a' cruthachadh mhisneachd ann an susbaint na seanail agus mar a tha sin a' freagairt gu leantainneach ri suidheachadh a tha a' sìor fhàs nas briste agus nas fharpaisich.

An dèidh prògram leasachaidh ioma-bhliadhna, chriochnaich sinn san luchair 2017, an gluasad gu àrainn stèidhichte air faidhle Àrd Dheifinisean (HD). Bha àite mòr aig ar luchd-obrach sa Chom-pàirteachas Saothrachaidh Dhidseataich (DPP) air feadh na RA agus sna ro-innleachdan a bha na chois agus, le bhith a' factainn comas ceangail earbsach agus aig astar luath, tha e comasach do MG ALBA a-nis a bhith ag obair gu furasta le ar com-pàirtichean aig a' BhBC air pròiseactan ro-roinnt le ríochdairean agus craoladairean air feadh na RA agus gu h-eadar-nàiseanta, a' gabhail a-steach an Aonadh Craolaidh Eòrpaich o chionn gohirid.

## MAOINEACHADH

Tha an nàdar cuingealaichte dhoirbh a tha air buidseat susbaint bhliadhnaile BBC ALBA – mu £11m bho MG ALBA agus eadar £6m agus £7m bhan BhBC – a' leantainn air a bhith na bhacadh mòr air a bhith a' dèligeadh ri na dùblain a tha ron t-seanail. Chan eil maoineachadh BBC ALBA ach a' ceadachadh 1.8 uair de shusbaint ùr gach là agus chan eil e comasach maoin gu leòr a chur ri trìomh ghnèithean leithid ionnsachadh, clann, dràma agus comadaidh. A bharrachd air a sin, chan eil an t-seanail ri faotainn ach air Deifinisean

## OVERVIEW

2017-18 was a challenging year for MG ALBA but there were also some signs of promise.

While the weekly reach of the television service continued its recent downward trend, viewer appreciation and awareness increased. The fall in television reach was most noticeable amongst users of Gaelic in the 16-44 demographic.

In response we created, in July 2017, a Digital Hub, drawing colleagues together in a concerted strategy to engage younger media consumers with Gaelic content on television, on devices and on non-TV platforms. Early successes and failures are helping to rapidly build up experience and knowledge, and we are confident in the promise of our new digital strategy to reach and engage that demographic who least use the linear channel.

At the same time, we are focused on offering bolder, clearer and better-promoted content propositions on BBC ALBA that have the potential to draw younger audiences. This helped to deliver a strong festive season performance for BBC ALBA, which saw the 16-44 core audience temporarily return to 2014 levels, creating confidence in the channel's content and its ongoing relevance even in the face of an increasingly fragmented and competitive landscape.

Following a multi-year upgrade programme, we completed, in July 2017, the successful transition to a fully High Definition (HD), file-based environment. Our staff played a key role in the UK-wide Digital Production Partnership (DPP) and related initiatives and, with the acquisition of reliable and high-speed connectivity, MG ALBA is now able to work seamlessly with our BBC partners and on shared projects with producers and broadcasters throughout the UK and internationally, including most recently the European Broadcasting Union.

## FUNDING

The seriously constrained nature of BBC ALBA's annual content budget – around £11m from MG ALBA and between £6m and £7m from the BBC – continued to act as a serious barrier to addressing the challenges facing the channel. BBC ALBA's funding only allows for 1.8 hours of first-run content per day and is not able to invest sufficiently in key genres such as learning, children's, drama and comedy. Moreover, the channel is only available in Standard Definition (SD), which is increasingly problematic for a broadcaster of

A dh'aindeoin sin, thug tuilleadh maoin bho Riaghaltas na h-Alba agus teachd-a-steach bho ghoireasan agus phrògraman, cothrom do MG ALBA £700k a bharrachd na bha sa bhuidseart againn a thasgadh ann am prògramadh ann an 2017-18, a' gabhail a-steach dealas àrd-amasach a thaobh comadaidh ùr, dàimheil agus tarraigeach air TBh agus air-loidhne nas fhaide air adhart ann an 2018.

Tha pasgan co-riochdachaidh de mu £5m, le còrr air £4m dheth air a maoineachadh le com-pàrtichean, mar fhianais air cruth-atharrachadh ionmhasail, cruthachail agus ro-innleachdail. Tha fàs anns an àireamh de sruthan maoin agus fàs anns na buadhan cruthachail a tha mòran de na riochdarean neo-eisimeileach againn a' leantainn, gu soirbheachail a' neartachadh na roinne agus a' toirt air adhart an taigse a tha sinn a' toirt do ar luchd-amhairc. Tha sinn an làn bheachd gum bi an t-Aonad Sgrion ùr aig Alba Chruthachail, a chaidh a stèidheadachadh le Riaghaltas na h-Alba ann an 2017-18, a' toirt tac do agus a' leudachadh a' chuspair seo còmhla rinn.

Gheibhearr tuilleadh conaltraidh mu maoineachadh BBC ALBA san Lèirmheas mu Ghniomhan agus Ghnothaichean.

## AMASAN

Bha grunnan shoirbheachasan ainmeil ann tron bhliadhna. Chaidh na h-amasan ionmhasail agus obrachail air fad a choileanadh, bha FilmG agus LearnGaelic air an coileanadh gu làdir agus chunnaic sinn meudachadh san dol an sàs sna meadhanan sòisealta, a' leudachadh mothachadh agus aonta a thaobh BBC ALBA agus ruigse TBh air feadh Alba gach seachdain a bha os cionn an amais a bha againn de 10%.

sports output at a time when other public service channels are now available in HD. The gap in service provision is illuminated by the proposed new BBC Scotland channel which will enjoy a content budget of £32.3m and carriage in HD. Without additional funding it will not be possible to address the significant content and service provision deficiencies in a planned way.

Nevertheless, additional Scottish Government funding and income from facilities and programmes allowed MG ALBA to invest £700k more in programming in 2017-18 than we had budgeted, including an ambitious commitment to new, engaging and attractive TV and online comedy for later in 2018.

A co-production portfolio of some £5m, of which over £4m is funded by partners, represents a breakthrough in financial, creative and strategic terms. The diversification of revenue streams and creative influences which many of our independent producers are pursuing is serving to strengthen our sector and improve our offer to viewers. We fully expect Creative Scotland's new Screen Unit, established by the Scottish Government in 2017-18, to support and grow this activity with us.

Further discussion on the funding of BBC ALBA can be found in the Activities and Business Review.

## OBJECTIVES

There were some notable successes during the year. Financial and operational goals were all met, FilmG and LearnGaelic performed strongly and we saw increasing engagement on social media, increasing awareness and approval of BBC ALBA and a Scotland-wide weekly TV reach that exceeded our benchmark target of 10%.

Although we were encouraged to see well over 1m content views on other digital platforms, iPlayer viewings did not reach our ambition of 5m and the weekly reach of BBC ALBA among the core audience settled below our target of 70%. Increased competition on the iPlayer and a decrease in TV viewership by the 16-44 age group were the key factors. It is increasingly clear that younger viewers need to find content on the digital platforms which they prefer and that it must be both vigorously promoted to, and easily discoverable by, them. These are significant challenges being faced by the whole of public service television.

We did not meet our objective of significantly increasing the hours per day of first-run programming on BBC ALBA. In 2017-18, BBC ALBA broadcast 1.8 hours per day, on average, of new content, of which 60% was provided by MG ALBA.

BBC ALBA's Gaelic television content is still, unfortunately, not available outside the UK. This remains an unfulfilled objective which we will address in the coming year.

## CHANGES IN MEDIA LANDSCAPE

The disruption caused to broadcasting by new technologies and non-linear brands affects minority language media as much, if not more, than English language broadcasting services. It is essential that Gaelic media content finds its place in this landscape. Public service television enjoys prominence in channel line-ups, with BBC ALBA being in the channel 7 slot on the Freeview EPG in Scotland, but public service content in the non-linear domain enjoys no such prominence. We will continue to encourage the regulator and Government to establish prominence standards for public service content on devices and non-linear platforms, so that Gaelic media content can be made more discoverable.

In this non-linear domain, it is encouraging that FilmG, which is delivered in partnership with Cànan Graphics Studio, continues to be such a success. The Awards were, for the first time, shown to TV audiences on BBC ALBA, evidencing a wider audience growth in the creative skills, talent and on-screen confidence of younger users of Gaelic across the whole of Scotland.

The proposed new BBC channel for Scotland is likely to be attractive to existing BBC ALBA viewers. It is a priority for us that the BBC and Ofcom ensure that the new channel will not negatively impact the value of BBC ALBA, and that the regulatory framework will create the conditions for both channels to grow the combined audience and public value of public service broadcasting in Scotland.

## OUTLOOK 2018-19

The disruption being experienced by the TV industry will continue. Nevertheless, MG ALBA continues to face the future with confidence, based on the knowledge that there is strong demand for Gaelic media product and signs of promise that our strategies are working. Increasing focus on partnerships and project collaborations with the new BBC Scotland

We will place particular emphasis on improving provision for young people, children and learners, fostering writing talent and continuing to internationalise our creative sector.



The remit of MG ALBA is to ensure that persons living in Scotland are provided with a wide and diverse range of high quality programmes in Gaelic.

MG ALBA fulfils its remit principally through BBC ALBA, the Gaelic television and multi-media service which it operates in partnership with the BBC. MG ALBA and the BBC have entered into a collaboration agreement that sets out the terms on which the two organisations run BBC ALBA, and the resources that they provide to the project. The partnership is overseen by a Joint Management Board, chaired by the Chief Executive of MG ALBA.

## BOARD & COMMITTEES

In 2017-18, the MG ALBA Board met on five occasions, under the chairmanship of Maggie Cunningham. The main areas addressed by the Board included the potential for resource-sharing with BBC Scotland in light of the upcoming new BBC Scotland channel; a review of policies; a review of MG ALBA's risk management procedures; accountability to, and engagement with, key stakeholders, including Ofcom, the Scottish Government and the UK Government; strategies to secure commitments from the BBC and from funders to fulfil ambitions that will require additional resources over the coming years; improving responsiveness to the needs and aspirations of users of Gaelic and a review of genre provision, particularly Children & Youth programming; and the commissioning of long-term programme production contracts (volume deals).

The Audit & Assurance Committee met on four occasions, under the chairmanship of David Brew. The Committee commissioned an internal audit of MG ALBA's risk management procedures and arranged separate workshops involving staff and members. A Corporate Risk Group has been established to ensure that a risk-aware culture is embedded in the organisation. The Committee also approved a plan of internal audit over coming years encompassing specific areas within the operational activities of the organisation. It reviewed and updated MG ALBA's corporate governance policies in line with current legislation and best practice. The Committee reviewed the staffing structure and approved remuneration arrangements in line with Scottish Government pay policy.

The Standards Committee met on four occasions, under the chairmanship of Jo MacDonald, in order to review BBC ALBA programme genres, language content in programmes and MG ALBA's contribution to radio. The Committee also considered MG ALBA's Gaelic policy, skills development

Taobh a-staigh nan goireasan a th' ann an-dràsta tha MG ALBA air ath-òrdanachadh agus ath-phrìomhachadh a dhèanamh gus goireasan a chuir gu ruige raointean prìomhachais, leithid an Aonad Dhidseatach.

strategies and social media platforms as well as conducting a review and appraisal of FilmG and LearnGaelic.

The Nominations Committee met once, in January 2018, under the chairmanship of Maggie Cunningham, establishing the Committee's remit and a Board skills matrix to assist with the recruitment of Members in the future.

## FUNDING

In addition to regular and additional funding from Scottish Government and income from facilities and programmes, various activities are helping source some additional content.

The BBC in 2017-18 contributed 33 more hours of content than the previous year and have confirmed that they will deliver weekend news bulletins on BBC ALBA from autumn of 2018.

Within current resources MG ALBA has reorganised and reprioritised to divert resource to priority areas, such as the Digital Hub.

In the first quarter of the year, MG ALBA entered into eight volume deals contracts with independent production companies for the supply of core programme genres, including versioned animation, factual and drama. The sports production contract extends for three years so as to align with available sports rights, the other contracts extend for four years. These deals provide value for money, accounting for approximately 85%-90% of MG ALBA-funded original annual channel output, as well as targeted audience satisfaction.

A BBC Scotland/MG ALBA review of joint support activities sought to identify potential efficiencies that could be reinvested in content for our Gaelic audiences. The findings from this report are being explored by a joint team and recommendations will be made to the BBC ALBA Joint Management Board and to the MG ALBA Board in summer 2018.

With our partner the BBC, MG ALBA has embarked on a portfolio of projects which are currently unfunded and for which financial support will be sought in the coming year. Chief among those projects is a new multi-media language

learning resource, which is urgently required if Gaelic media is to make a fuller contribution to increasing the number of learners of Gaelic and the number of those who successfully progress to proficiency in Gaelic.

MG ALBA has put significant emphasis on working more closely with producers and agencies to increase the number of Gaelic content collaborations with other broadcasters, producers and agencies, in the UK and internationally. The key goals of that strategy are to find new external funding and value for Gaelic programmes, to grow the international business relationships of the Gaelic media sector and to diversify creative influences on Gaelic content. That strategy is beginning to show promise. The Gaelic creative sector is now working with a multi-million pound portfolio of projects with partners from all points between Canada and China, in which MG ALBA is, on average, a 15% funder.

Co-working with Bòrd na Gàidhlig has already enabled MG ALBA to lead on the next stage of LearnGaelic's development and to commission new online language learning resources from Uist Film for delivery in 2018-19.

## FINANCIAL & OPERATIONAL PERFORMANCE

In 2017-18 MG ALBA spent £9.8m directly with 24 different production companies on the creation of 432 hours of programmes. Of that, £8.9m was spent with the independent production sector, much of it in tandem with a package of measures intended to foster the development of talent, skills and Gaelic language.

The year saw income for MG ALBA of £13.8m (2017: £13.1m), of which £13.5m (2017: £12.865m) came from Scottish Government grant-in-aid and £348.5k (2017: £280.3k) came from project funding and charges for services and facilities.

The end-of-year Statement of Comprehensive Income reported a surplus after taxation of £20.2k compared with a deficit of £132.2k in 2017. This reflects movements in fixed assets and productions to be transmitted and is therefore the net result of the depreciation charge, capital expenditure and movements in working capital. In 2017 a review was undertaken on the allocation of staff resources to the cost centres of administration, channel management and channel content with the salary costs being reallocated in line with each area's resource utilisation. This has contributed to a 19% reduction in administrative costs in 2017-18.

The end-of-year Statement of Financial Position shows programmes in stock or in production of £4.4m (2017: £3.5m) and year end cash reserves of £37.8k (2017: £166.5k), both in line with policy. Significant future commitments of £19.8m over four years are also disclosed this year; these represent mainly multi-annual programme supply contracts agreed in the first half of 2017 and which will last until 2020 or 2021.

The transition to fully HD, file-based workflows was a significant achievement for MG ALBA's in-house teams and the independent production sector. To the credit of all involved, it was completed without impact on BBC ALBA delivery or quality. Although BBC ALBA does not yet broadcast in HD, it is fully prepared and can supply the iPlayer with HD quality content.

In the year, MG ALBA's channel operations and presentation teams delivered 100 hours of junctions and around 443 hours of broadcast-compliant media to BBC ALBA playout, as well as supporting productions and events such as FilmG.

## OTHER ACTIVITIES

In 2017-18 the establishment of the Digital Hub proved successful in attracting younger consumers of content by providing short pieces on non-tv platforms appealing to a section of the audience most likely to consume non-linear content.

LearnGaelic, supported by Bòrd na Gàidhlig and with guidance from the University of Glasgow, created a new planning framework for the creation of future audio-visual learning resources. The new framework is based on the Common European Framework of Reference for Languages, which provides a standard basis for measuring language skills, and will allow future media learning resources to be created in a planned way and in harmony with other initiatives. A collaboration with Glasgow School of Art's School of Simulation and Visualisation will allow LearnGaelic to co-design and co-create learning resources with users. The LearnGaelic website continued to grow in terms of usage and social media engagement.

San Lùnastal 2017 chaith MG ALBA ann an cùmhant le Eforensics gus sgrùdadh in-thaigh a dhèanamh air modhan-obrach manaidseadh riosg na buidhne. Tha toirt gu buil molaidhean na h-aithisg air an cur a-mach ann am barrachd doimhneachd san Aithris Riaghlaidh.

MG ALBA continued to offer development opportunities for young people and others to make the transition into industry and for content creators to access continuing professional development. MG ALBA's contribution in priority skills areas included two apprenticeships in digital media, a Masters scholarship in TV Fiction Writing and industry placements for students.

The 10<sup>th</sup> annual FilmG competition continued to support media participation in schools and communities. The awards ceremony for FilmG, held in the Old Fruitmarket in Glasgow in February 2018, showcased the skill, talent and linguistic ability of young people from a wide range of communities, schools, colleges and universities.

In August 2017 MG ALBA contracted with Eforensics to carry out an internal audit of the organisation's risk management procedures. The implementation of the report's recommendation is set out more fully in the Governance Statement.

The 2017-18 financial year saw eight volume contracts agreed. The eight companies are Bees Nees Media, MacTV, Caledonia TV, Midas Media, Obh! Obh! Productions, Solus Productions, Nemeton Scotland and Young Films.

A new communications company, Electrify, was appointed. SPFL football rights were also agreed.

Content through the year saw co-productions leveraging in high-value, rich content, as well as new talent being showcased and highly deserved awards.

**Trusadh (MacTV)** continues to deliver high quality storytelling using a range of styles to best showcase the topic being explored. Among the output, two programmes, **Sùlaisgeir: an t-Sealg** and **Sùlaisgeir: Na Sealgairean** portrayed the centuries-old custom of hunting the guga/young gannet. The first of these deservedly won recognition at the Chicago International Television Festival.

International co-productions are increasingly enriching the schedule, with highlights including **Luther 500: An t-Strì Spioradail** (produced by *Waddell Media* and co-funded by *BBC NI*, and the *ILBF*), which looked back 500 years to when Martin Luther started a revolution. Two sporting documentaries co-commissioned with *TG4* were among the other international co-productions which created impact in the schedule. One was **Benny** (co-produced by *MacTV* and *Square One Productions* with funding from *Creative Scotland* for a theatrical cut), the remarkable story of Scotland's first boxing world champion boxer, Glasgow's Benny Lynch, and multi-award winning **Rocky Ros Muc** (*Below the Radar* with funding from the *Irish Film Board, ILBF* and the *BAI*), told the story of Sean Mannion's life and boxing career, and was long-listed for an Academy Award.

In Music and Events, **Belladrum 2017 (BBC Gàidhlig)** saw exciting, irreverent non-linear content complementing the channel content and this formula continued successfully for coverage of the **Am Mòd Nàiseanta Rìoghail (BBC Gàidhlig)**. This year's Mod coverage saw the live broadcast extended to include the rural choirs' competition on the Thursday afternoon for the very first time. This year's **Cèilidh na Blìadh'n' Ùire (BBC Gàidhlig)** was presented from the Isle of Skye by Cathy MacDonald and Niall Iain MacDonald, and musical director Ingrid Henderson. **Òrain nan Gàidheal (Bees Nees Media)** was a sumptuous, ambitious showcase

Ann am prògraman Chloinne, am measg na bha ri fhaicinn bha **Raven/Fitheat (BBC Children's Productions agus BBC Gàidhlig)** – sreach chloinne mu dhàn-thuras do-chreidsinneach bho CBBC – a chaidh a dhèanamh comasach tro ath-thionndadh susbaint bhon BhBC. Am measg na bha ri fhaicinn sna Naidheachdan bha an taghadh coitcheann 2017. Ann an Cùisean Làitheil, thòisich an 25<sup>th</sup> sreach de **Eòrpa (BBC Gàidhlig)** agus bhuanach e duais cùisean làitheil BAFTA Alba airson a' phòrgraig air ciomaich Ghuantanamo.

A' cleachdadadh fòrmat ùr nas gjorra nan àbhaist, fhuair sinn **Dhan Uisce (BBC Gàidhlig)** agus rionnag ùr eile BBC The Social, Calum MacIIEathain, ag innse dhuinn mun ghaol a tha aige a bhith a' snàmh gu nàdarra ann an lochan agus aibhnichean iomallach agus neo-thruailte. Ann an **Ceathrar air a' Chuiltheann (Magic B)** chunnait sinn sgeulachd cheathrar dheugairearan a' toirt ionnsaigh air a' Chuiltheann san Eilean Sgitheanach. Mu dhereadh, ann an Dràma, fhuair sinn dràma chloinne bhon Aonadh Craolaidh Èòrpach (EBU), **Mystique No 375 (Sorbier)**, far an d' fhuair sinn actadh agus ceòl air leth. A thuilleadh air gu bheil sgeama dràma an EBU na bhuanachd airson an luchd-amhairc, thathas ga cleachdadadh mar inneal leasachaидh a thaobh stiùireadh, sgrìobhadh agus ann a bhith a' cruthachadh ceòl tùsail. of Gaelic's finest contemporary singers joined by the BBC Scottish Symphony Orchestra. **Lorient is Alba: Scotland's Year (Bees Nees Media)** showed some of Scotland's very best musical artistes and groups performing at the Interceltique Festival in Lorient, including Tide Lines and Hò-Rò.

Sports coverage included the new format of the **PRO14 competition, women's football** at domestic and international level, extensive **Premiership football** coverage and **shinty (Nemeton Scotland)**. Two new female sports presenters, Iona Whyte and Megan MacLellan, are being developed. Sports documentary included **Tannadice '87 (Purpletv)**, the 30<sup>th</sup> of Dundee United FC reaching the final of the UEFA Cup, and **Breab agus Buaidh (Matchlight)**, which followed Scotland's Women's Team as they entered the final stages of the Euro 2017 finals.

In Children's programming, highlights included a new series being enabled through versioning of BBC content: **Raven/ Fitheat (BBC Children's Productions and BBC Gàidhlig)**, a CBBC children's fantasy adventure series. News coverage included the 2017 general election. In Current Affairs, **Eòrpa (BBC Gàidhlig)** began its 25<sup>th</sup> series and won the BAFTA Scotland current affairs award for its programme on Guantanamo Detainees.

The mid-form duration **Dhan Uisce (BBC Gàidhlig)** saw another rising talent, BBC The Social star, Calum MacLean, explain his passion for wild swimming in remote and unspoilt lochs and rivers. **Ceathrar air a' Chuiltheann (Magic B)** followed four school leavers from Glasgow tackle the hardest climb in the UK: the Cuillin Ridge. Finally, in Drama, the children's European Broadcast Union (EBU) drama **Mystique No 375 (Sorbier)** saw striking performances and a beautiful soundtrack. As well as an important audience proposition, the EBU drama scheme is used as a development vehicle in relation to directing, writing and music for original soundtrack. It benefitted from the tax credit available to children's production. Series four of **Bannan (Young Films)** was broadcast with strong audience appreciation. Drama content was further augmented by the period Irish language drama **An Klondike (Abu Media)**, the televisation of the stage play, John Murray's **Briseadh na Cloiche (Ceòl's Craic Productions)** and a short season of Iain Crichton Smith's work to mark the 90<sup>th</sup> anniversary of his birth.

An ann 2017-18 bha ruigse BBC ALBA leis an luchd-amhairc Gàidhlig aig 62.1%. Bha an luchd-amhairc nàiseanta aig 11.3%. Lean dèanadas leis an luchd-amhairc Gàidhlig os cionn aois 45 a bhith làidir. Coltach ri seanailean craolaidh seirbheisean poblach loidhneach eile, tha luchd-amhairc nas òige dùbhlanach agus tron bhliadhna dh'atharraich fòcas MG ALBA gus làthaireachd a bharrachd air ùrlaran neo-loidhneach a chruthachadh. Ghabh seo a-steach stèidheachadh duilleag Facebook BBC ALBA.

### *Neo-loidhneach*

## AUDIENCES

### *Linear*

In 2017-18 BBC ALBA reach in the Gaelic audience was 62.1%. The national audience was 11.3%. Performance with the over-45 Gaelic audience continued to be strong. Like other linear public service broadcast channels, younger audiences are challenging and MG ALBA's focus shifted during the year to ensure an increased presence on non-linear platforms. This included the establishment of a BBC ALBA Facebook page.

### *Non-linear*

The objectives of BBC ALBA's non-linear presence are:

- to create a bold, confident presence for BBC ALBA on platforms where younger audiences consume media using short form content (archive based; some originated)
- to complement the channel content, including live channel content, using Facebook Live or Periscope on Twitter, or for example using SnappyTV to clip and share live video content as it happens
- to use these platforms for promotional content that drives viewers to the channel - although this final element must be handled carefully given that there is evidence that heavy handed promotions can be off-putting to that demographic.

BBC ALBA Facebook was established in August and is showing steady growth. There were a total of 1.24m views on BBC ALBA Twitter and Facebook over the course of the financial year. The average weekly reach for BBC ALBA Facebook since its establishment is 35,000. This is a strong start. It has established the bolder presence that was sought and we expect this presence to grow: both in terms of confidence, and in terms of presence on other platforms. As well as a further opportunity for the channel's in-vision presenters to strengthen their relationship with the audience, these platforms are also powerful opportunities for BBC ALBA to showcase and develop talent, e.g. Hannah McKirdy and Iain Beggs at Belladrum 2017, and Megan McLellan and Iona Whyte in sports coverage. The use of Snappy TV (where rights permit) on BBC ALBA platforms successfully complements live event coverage, particularly in music and sport: Na Trads 2017 trended on Twitter across the UK ahead of BBC One's Strictly Come Dancing at one point,

## TRÈANADH

Tha na tha MG ALBA a' cur ri trèanadh a' gabhail a-steach trèanadh cànan, preantasachdan, greisean gnìomhachais oilleanaich, bursaraidhean, leasachadh leantainneach proifeasant, leasachadh sgrìobhaidh agus a' toirt taic do leasachadh chompanaidhean tro làthaireach aig margaidhean.

Chaidh dà dhiofar trèanadh cànan a thairgse do luchd-solair BBC ALBA agus chaith an lìbhrigeadh le Ruaraidh MacIleathain tro Chomhairle nan Leabhrachair. Bha aon chùrsa ag amas air luchd-ionnsachaidh, le cursa nas fhaide ag amas air luchd-labhairt fileanta. A thuilleadh air sin, tha fuasglaidhean nas pearsanta a rèir feumalachdan luchd-obrach a dhìth air cuid de chompanaidhean agus tha MG ALBA a' toirt taic dhan seo cuideachd. Ann an 2017-18 mhaoinich MG ALBA an dàrna sgeama Preantasachd aig a' BhBC a thuilleadh air preantasachd bho sgeama Chomhairle nan Eilean Siar. Tha MG ALBA a' leantainn le bhith a' maoineachadh greisean-gnìomhachais airson oilleanach an dàrna bliadhna de Dhioplòma nam Meadhanan Gàidhlig aig Sabhal Mòr Ostaig. Fhuair triùir phroifeiseantaich òga cothrom a bhith an làthair aig Fèis nam Meadhanan Ceilteach ann an Eilean Mhanainn fo sgeama bursaraidh MG ALBA.

Tha cùmhiant fad-ùine Young Films airson Bannan a' tabhann cothrom díleab de thàlant a chruthachadh agus chaith taic a chuir gu ruige obraichean mar Deasaiche Foghlainneach, Neach-taic Camara Foghlainneach agus dà Stiùiriche Foghlainneach. A thuilleadh air sin chaith taic a thoirt do dhà sgrìobhadair air Bannan a dhol chun Lab Dràma TBh Eòrpach ann am Berlin.

Tha cuideachd taic air a chur ri leasachadh leantainneach phroifeasant agus ann an 2017-18 ghabh seo a-steach obair deasachaidh, le stiùireadh ioma-chamara mar fhòcas sa gheàrr-ùine.

Lean leasachadh chompanaidhean gus co-riochdachaidhean a dhèanamh comasach, le trì companidhean a' faighinn taic gus a bhith an làthair aig margaidhean. Airson a' chiad uair, bha aonad aig BBC ALBA aig MIPCOM gus inbhe na seanail agus luchd-solar

while in sport, a clip of a PRO14 try gained almost 160,000 impressions across the globe. On BBC iPlayer there were 4.1m views of BBC ALBA content.

## TRAINING

MG ALBA's investment in training covers Gaelic language training, apprenticeships, student placements, bursaries, continuing professional development, writing development and supporting company development through attendance at markets.

Two forms of Gaelic language training were offered to BBC ALBA suppliers and delivered by Ruairidh Maclean through the Gaelic Books Council. One course was aimed at beginners, and a longer course served fluent speakers. Additionally, some companies prefer bespoke solutions dependent on staff needs and MG ALBA supports this also. In 2017-18 MG ALBA funded its second BBC Scotland Gaelic apprentice as well as an MG ALBA apprentice under Comhairle nan Eilean Siar's scheme. MG ALBA continues to fund the placements for the second year students of Sabhal Mòr Ostaig's Diploma in Gaelic Media. Three young professionals attended the Celtic Media Festival in the Isle of Man under MG ALBA's bursary scheme.

Young Film's long-term Bannan deal offers an opportunity to create a legacy of talent and the positions of Trainee Editor, Trainee Camera Assistant, and two Trainee Directors were supported. In addition two Bannan writers were supported to attend the European TV Drama Lab in Berlin.

Continuing professional development is also supported and in 2017-18 this principally comprised editing, with multi-camera directing to be a focus in the immediate future.

Development of companies in order to facilitate co-productions continued apace with three companies being supported in attendance at markets. For the first time, a physical BBC ALBA presence was taken at MIPCOM in order to facilitate these companies' interactions and those

## SGRÌOBHADH

Tha MG ALBA a' leantainn le seilbheachd ann an leasachadh sgrìobhaidh. 'S iad na priomh raointean seilbheachd: Bannan, com-pàirteachadh ann am film goirid chloinne an EBU (a thathas a' cleachdadh mar inneal leasachaidh airson sgrìobhadh, stiùireadh agus ceòl air a sgrìobhadh a dh'aona ghnothach airson a' phrògraim), agus mu dheireadh, Sgoilearachd MG ALBA airson sgrìobhadh ficsean telebhisein ionnsachadh aig Oïlthigh Chailleanach Ghlaschu. A thuilleadh air sin, am-bliadhna airson a' chìad uair, chaidh taic a thoirt do neach-tagraidh Gàidhlig air greis-còmhnaidh sgrìobhaidh Young Films Foundation. Chaidh leasachadh eile a dhèanamh comasach tro choimisean airson comadaidh ùr air BBC ALBA agus tha seo air còrr is 100 pìos ùr bho 18 sgrìobhadairean, le timcheall air leth dhiubh a tha ùr gu TBh. ## STUTHAN FÈIN CHRUTHAICHE (UGC)

Bha MG ALBA ag amas air a bhith a' leasachadh iomairtean ugc gus susbaint Gàidhlig a leudachadh am measg an t-sluagh. Ged a chaidh #vlogamhòid a ruith a-rithist, bha isleachadh san àireamh bho 2016 agus bha an iomairt air a chuingealachadh ri linn gainnead ghoireasan taobh a-staigh MG ALBA. Thèid an iomairt seo a chur a-mach gu cumhnant airson na h-ath bhliadhna ionmhais.

of MG ALBA executives. Once more we worked closely with Scottish Development International, Northern Ireland Screen and the Irish language Broadcast Fund (ILBF). The relationship with the ILBF is set to develop further, into additional markets, alongside other Celtic broadcasters. The dividends for this investment are clear: international co-productions enable increased content for the channel (most recently valued at £5m for BBC ALBA) and prime companies to take advantage of opportunities in other territories. The companies that are supported and incentivised to do this are creating highly effective networks which benefit BBC ALBA, Scotland's creative economy, and enable their own development.

## WRITING

MG ALBA continues to invest in writing development. The key elements to the investment are: Bannan, participation in the European Broadcast Union's children's short film, which we use as a development vehicle for writing, directing and original score and finally, the MG ALBA Scholarship for Caledonia University's MA in TV Fiction writing. In addition, this year for the first time a Gaelic candidate on the Young Films Foundation's writing residency was also supported. A further development in 2017-18 was enabled through the commissioning of a sketch comedy brand for BBC ALBA: this has created over 100 original pieces from 18 writers, around half of whom are new to TV. The search for the new writing talent for this commission was undertaken in partnership with the BBC Writersroom and the callout received an unprecedented number of submissions – more than UK national schemes receive.

## USER GENERATED CONTENT (UGC)

MG ALBA aimed to further develop ugc initiatives to increase in grassroots Gaelic language content. Although #vlogamhòid was run again, numbers fell from 2016 and the initiative was constrained by lack of internal MG ALBA capacity. This element will be externally contracted for the next financial year.

## FILMG

## FILMG

This was FilmG's 10<sup>th</sup> year and it saw a record-breaking number of films entered - with the youth category receiving 63 films. This was a record number for youth entries; adult entries fell, but the standard of adult entries was very high.

Twenty one of the children's entries were from independent film makers, which means the films are made without any professional adult support. This number is over double that of last year and is the highest ever. This is important because it bolsters efforts to encourage Gaelic speaking young people to create their own content – in Gaelic.

This year's ceremony saw Gaelic icons such as Cathy Macdonald, Donnie 'Dotaman' and Griogair Labhraidh present the awards to the winners. They were joined by Greg McHugh ('Gary Tank Commander'), Brian Vernel of Star Wars and A Casual Vacancy and Aisha Toussaint, of the BBC Children's programme Raven (and who also starred in the Gaelic version screened on BBC ALBA).

The event was live streamed again and, for the first time, an edited highlights programme was shown on BBC ALBA on the Sunday following the awards. This was followed by the broadcast for the first time of four of the best films received to date.

Once more, the event trended on social media on the evening of the ceremony.



## LEARNING

The establishment of a new multiplatform language learning initiative, across television, radio, online and social media, is a clear ambition in MG ALBA's Lèirsinn 2021. Work undertaken during the year will form the basis of a project that will seek funding in 2018-19.

In 2017-18, the LearnGaelic team worked on the creation of a new planning framework for the creation of future audio-visual Gaelic learning resources. This seeks to establish a pedagogical route - or commonly agreed learning outcomes for the various stages of the learning journey - as a basis both for the creation of future media learning resources and the best use of current resources on BBC ALBA, Radio nan Gàidheal and LearnGaelic.

LearnGaelic continued to enjoy steady growth in online usage and social media engagement. Notable successes include seasonal video content such as the Advent Calendar in Gaelic,

LearnGaelic, with support from Bòrd na Gàidhlig and the Scottish Government, also commissioned a suite of new resources for LearnGaelic. Uist Film will create a series of social media and online video content designed to raise awareness of Gaelic and inspire more people to start learning Gaelic and continue their journey towards competence and then fluency. The same company, which is the production arm of Taigh Chearsabhagh, will also create two new audio-visual learning tools: a pronunciation guide for beginners; and practical video guidance for learners on the most commonly experienced grammar challenges. Collaboration with the Glasgow School of Art's School of Simulation and Visualisation will allow those tools to be tested with learners and refined in time for launch in Autumn 2018.

MG ALBA was established (as Seirbheis nam Meadhanan Gàidhlig or the Gaelic Media Service) under the provisions of the Communications Act 2003, Sections 208-210, to ensure that a wide and diverse range of high-quality programmes in Gaelic is broadcast or otherwise transmitted so as to be available to persons in Scotland.

MG ALBA is empowered to make programmes and can hold broadcast licences other than those specifically listed in Section 208 (4B) of the Communications Act 2003. It has subsumed funding powers and responsibilities in relation to financing of Gaelic programmes, training, research and related activities under Sections 183 and 184 of the Broadcasting Act 1990, Sections 32 and 95 of the Broadcasting Act 1996 and related Schedules.

MG ALBA is committed to high standards of corporate governance and ethical behaviour. As far as is appropriate to the circumstances of MG ALBA, the Board seeks to comply with relevant provisions of the UK Corporate Governance Code issued from time to time by the Financial Reporting Council.

The Board has overall responsibility for ensuring that MG ALBA maintains a system of internal controls that minimise risk, safeguard MG ALBA's assets and interests, and provides the Board with reasonable assurance of the reliability of the financial information used internally and for external publication.

Although no system of internal controls can provide absolute assurance against material misstatement, loss or mismanagement of MG ALBA's assets, the systems in place are designed to identify matters to the members that require attention on a timely basis so that they may be considered and dealt with appropriately.

The composition and appraisal of the Board is determined by Ofcom with the approval of the Scottish Ministers. This means that the diversity of the Board is a matter for Ofcom and in 2017-18 comprised 44.5% female and 55.5% male representation. The Board is comprised of up to 12 members including the Chairperson. Each Board member serves for a period of up to four years. The Board must include Members nominated by Highlands and Islands Enterprise, the BBC and Bòrd na Gàidhlig. Ofcom must

The Board has established three committees to assist in the discharge of its functions.

The Audit & Assurance Committee advises the Board on MG ALBA's risk management, internal controls and staff remuneration policy. The Board delegates the practical management of the external audit to the Audit Committee, who are responsible for considering the audit plan and audit findings in depth. The current contract for external audit is now in its final year. The Audit Committee will, in due course, make a recommendation to the Board as regards the appointment or reappointment of auditors, which will also require the consent of Ofcom in terms of the Communications Act 2003. The Committee also advises the Board on the findings of internal audits, which focus annually on individual areas of the business.

The Standards Committee advises the Board on media content broadcast by BBC ALBA, training and research.

The Nominations Committee was established in 2017-18 to help with effective succession planning by ensuring that any Board member skills requirements are promptly identified and by assisting Ofcom in the formal recruitment process for new members.

The Board and its committees periodically review and revise policies and corporate documents, which are available at [www.mgalba.com](http://www.mgalba.com).

The MG ALBA Board, Audit & Assurance Committee and Standards Committee meet at least quarterly. The Nominations Committee meets at least once annually. In 2017-18, the Board took advice from its Committees and dealt with the matters raised by them.

This piece of work was completed in autumn 2017 and reported to the Committee in November 2017 where the report's recommendations were accepted in full. An Implementation Plan was then sought from management.

The revised model for Risk management is based upon the undernoted risk hierarchy.

The Board appoints the Chief Executive, who is responsible for ensuring the propriety, regularity and value for money of MG ALBA's expenditure. The Chairperson is in regular contact with the Chief Executive, who has day-to-day responsibility for all aspects of MG ALBA activities. Every three months the Senior Management Team - comprising the Chief Executive, Director of Finance and Director of Strategy & Partnership - consider quarterly reports on all aspects of MG ALBA's activities in detail. Quarterly reporting packs are presented to the Standards Committee and to the Audit & Assurance Committee, and thereafter to the Board. In addition, the Senior Management Team meets at least monthly to oversee the implementation of the annual Operational Plan, to deal with financial affairs and to address other business and staff matters.

MG ALBA's external auditors discuss with the Board any reportable weaknesses identified during their annual audit. Significant findings and risks are examined and are subject to appropriate action. No significant weaknesses were identified in 2017-18.

The Board adopts an annual Operational Plan which seeks to make progress against the objective identified in MG ALBA's 5-year strategy, Lèirsinn 2021. The Operational Plan also identifies areas in which MG ALBA activities contribute to the Scottish Government's National Outcomes. Performance against the 2017-18 Plan is set out in the statement of objectives and outcomes on page 26.

Budget heads are monitored monthly by reference to the parameters set out in the Operational Plan. Reports and accounts are prepared for management and for the Board.

The Chief Executive has overall responsibility for ensuring that good governance regarding Risk Management is properly discharged and that the Board and its committees have sufficient assurance that key strategic risks are being appropriately managed.

In January 2018 a series of four all-staff risk awareness sessions was held by Eforensics, the consultants who undertook the internal audit assignment, and the Corporate Risk Group was constituted and began its work, including training. In March 2018 a Board Risk Workshop focused on MG ALBA's risk appetite and considered in detail what constituted quantitative and qualitative material risks to the organisation.

In parallel with the change programme associated with the internal audit, the organisation has managed risk through the Audit & Assurance Committee. Key risks considered, and actions taken, during the year to 31 March 2018 have concentrated on:

- Securing an appropriate new partnership agreement with the BBC;
- Managing within finite revenue resources in an inflationary environment;
- Countering falls in claimed audience reach; and
- Addressing gaps in the demography served, especially in the younger age bands.

The Senior Management Team is responsible for ensuring compliance with the Environmental Management Plan and ongoing action plans. The Senior Management Team receives regular reports on HR and Health and Safety matters. Health and Safety certificates for all MG ALBA premises are renewed annually and a report sent to the Board.

### BASIS OF PREPARATION

The financial statements have been prepared in accordance with International Financial Reporting Standards (IFRSs) as adopted by the European Union. IFRS includes the standards and interpretations approved by the International Accounting Standards Board ("IASB") and interpretations issued by the International Financial Reporting Interpretations Committee ("IFRIC").

The accounts have been prepared on the historical cost convention on a going concern basis.

### GOING CONCERN

The Seirbheis is cognisant of its reliance on the Scottish Government ministers' continued financial support at appropriate fiscal levels to maintain its operations to satisfy the BBC ALBA partnership with the BBC. The Seirbheis can reasonably expect that it will have adequate resources to continue in operational existence for the next twelve months. For this reason, it continues to adopt the going concern basis in preparing the accounts.

The principal accounting policies have been applied consistently in relation to the Seirbheis' accounts.

### INCOME

Income grants received from The Scottish Government and other organisations are credited to the Statement of Comprehensive Income in the year to which they relate, subject to the deferral of any grants received which were used to fund productions yet to be broadcast at the year end. This deferred income will be recognised when the related productions are expensed to the Statement of Comprehensive Income as outlined in the separate policy for production contracts as detailed below.

Objective evidence of impairment for a portfolio of receivables could include the Seirbheis' past experience of collecting payments, an increase in the number of delayed payments in the portfolio past the average credit period, as well as observable changes in national or local economic conditions that correlate with default on receivables.

For financial assets carried at amortised cost, the amount of the impairment is the differences between the asset's carrying amount and the present value of estimated future cash flows, discounted at the financial asset's original effective interest rate.

### CRITICAL ACCOUNTING JUDGEMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Seirbheis' accounting policies, which are described in note 1, the members are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

#### *Critical judgements in applying the Seirbheis' accounting policies*

The following are the critical judgements, apart from those involving estimations (which are dealt with separately below), that the Members have made in the process of applying the Seirbheis' accounting policies and that have the most significant effect on the amounts recognised in financial statements.

- Valuation of Productions to be Transmitted

The Seirbheis recognises the valuation of inventories: productions to be transmitted as being the purchase value of broadcasting rights purchased from producers. The value of these rights is considered expensed on first transmission of the programme with repeats under the acquired licence being of negligible monetary value. As a result of this decision, the value of productions to be transmitted disclosed in the Statement of Financial Position

The channel is operated under the terms of the Collaboration Agreement between MG ALBA and the BBC. The Seirbheis recognises its reliance on the Scottish Government ministers' continued financial support at appropriate fiscal levels to maintain its operations to satisfy the BBC ALBA partnership as being key to the delivery of MG ALBA's functions. After making enquiries, the members are satisfied that the ongoing relationship will continue and have therefore adopted the going concern basis in preparing the accounts, as explained in note 1.

Credit risk arises from cash and cash equivalents, deposits with banks and other institutions, as well as credit exposures to customers, including outstanding receivables and committed transactions.

For banks and other institutions, only independently rated parties with a minimum rating of 'A' are accepted.

Customers are assessed, taking into account their financial position, past experience and other factors, with individual credit limits being closely monitored throughout the year.

No recoverability issues were noted with debtors in the period, and no losses are expected from non-performance by any counterparties in relation to deposits.

### Liquidity risk

The table below analyses the financial liabilities into relevant maturity groupings based on the remaining period at the Statement of Financial Position to the contractual maturity date. The amounts disclosed in the table are contractual undiscounted cash flows and represents the expected maturity profile of the liabilities. Balances due within 12 months equal their carrying value as the impact of discounting is not significant.






